Splash implements water, sanitation, and hygiene (WASH) solutions for children in urban poverty. We work in some of the biggest, most densely populated cities in Asia and Africa to ensure that children lead healthier lives. To reach the greatest number of kids cost-effectively, we focus on child-serving institutions like orphanages, schools, shelters, and hospitals. Since 2007, Splash has completed over 1,700 projects across eight countries in Asia and Africa, benefiting more than 400,000 children daily.

South Asia: By the end of 2017, Splash had reached over 170,000 children daily in Kathmandu, Nepal; Kolkata, India; and Dhaka, Bangladesh with our holistic WASH program. Customized for each country and project site, this program includes installing water filtration systems, increasing water storage, installing drinking and hand washing stations, conducting hygiene education through training teachers and facilitating student hygiene clubs, holding soap drives and event days, as well as rehabilitating and constructing sanitation facilities. At every new site, Splash commits to future maintenance and service of the systems, including training and spare parts. Splash works with government agencies, NGOs, and the private sector to catalyze locally rooted, sustainable solutions. In Nepal, Splash continued to pilot a new kiosk model wherein schools are able to sell excess purified water to the broader community, with proceeds going to the school to pay for the service and maintenance of the WASH infrastructure.

Sub-Saharan Africa: Splash works in Ethiopia, the second largest country by population in Africa. By the end of 2017, Splash had reached over 45,000 children daily in Addis Ababa, the nation's capital, with our holistic WASH program. Customized for each project site, this program includes installing water filtration systems, increasing water storage, installing drinking and hand washing stations, conducting hygiene education through training teachers and facilitating student hygiene clubs, holding soap drives and event days, as well as rehabilitating and constructing sanitation facilities. At every new site, Splash commits to future maintenance and service of the systems, including training and spare parts. Splash works closely with the Addis Ababa Education Bureau, as well as the municipal agencies for health, finance, construction, and water and sewerage.

East Asia & Pacific: Splash ensured clean water for 185,000 children daily in Cambodia, China, Thailand and Vietnam. In China, Splash reached our ten-year goal of ensuring that every orphanage in China has clean, safe water, serving some 1,100 orphanages across 32 provinces. In Cambodia, Splash also implemented school-based hygiene programs, including the installation of hand washing stations, formation and training of student hygiene clubs that teach other students about the importance of hand washing with soap, and coordination of school-wide soap drives and other event days. In both China and Cambodia, Splash explored options for an eventual transition from a charity model to a self-sustaining local enterprise.

Any and all questions and comments are addressed by the Splash Director of Finance who engages additional experts whenever relevant or necessary.

Form 990, Part VI, Line 12c: On an annual basis, all Splash officers and directors are required to review the Organization's conflict of interest policy and indicate their compliance in writing. If any potential conflict of interest is raised, in fact or appearance, the Board of Directors will ask any interested persons to recuse themselves from any discussion or vote before determining its response. The Board of Directors reserves the right to disallow any transactions or arrangements by a majority vote of the disinterested directors.

Form 990, Part VI, Line 15: The Board of Directors reviews the Executive Director's compensation each year in executive session. The Executive Director is recused from these sessions so that none of the members involved in the determination of compensation have a conflict of interest. The directors consider salaries of executives with similar responsibilities and in similar sized organizations as well as the financial needs of Splash before determining the salary each year. The deliberation and decision are documented in the minutes of the executive session contemporaneously. The Executive Director and the management team use compensation reports and comparability data in determining the salaries of other staff.
